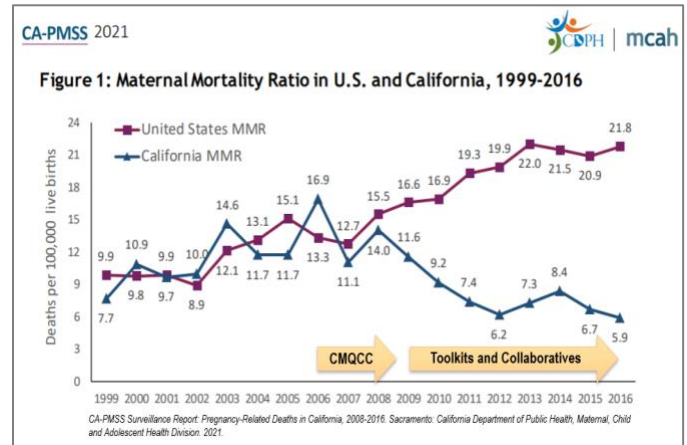


CMQCC SUCCESSES

The dramatic decline in our statewide maternal mortality rate, as depicted by the graph’s blue line, speaks to the power of collaborative action. Together, we can make impactful change!
